






### VAF INDIVIDUAL JF






### VAF TOTAL MG






### VAF JF vs. VAF MG







### % VARIACAO VAF INDIVIDUAL JF












### ÍNDICE DE PARTICIPAÇÃO MUNICÍPIO JUIZ DE FORA





% variação INDICE CONSOLIDADO JUIZ DE FORA






### TOT\_VAF SETORES ANO 2024






### VAF ano 2024 cnae SETORES
